#### Good Vibrations You Can Wear

Haptic\* technology delivers a way to feel music through skin for hearing challenged.

Jay Alan Zimmerman, a deaf composer and musician, used to position himself near loudspeakers, straining to feel the vibrations of songs he could not hear. So when offered to test a new technology, a backpack known as a haptic suit, designed for him to experience music as vibrations on his skin – a kickdrum to the ankles, a snare drum to the spine – he was excited.

Developed by the company *Music: Not Impossible*, the device consists of two ankle bands, two wrist bands and a backpack that fastens over the ribcage. The suits are unique in that the devices turn individual notes into specific vibrations. The development of the suits has benefitted from recent advancements in microprocessors, wireless technology, batteries and artificial intelligence, all key components in the emerging market of wearable haptic devices.

Originally a mission to develop a way to transmit the experience directly to the brain, it has expanded to a goal of creating a tactile experience of music that was available for everyone, including people without hearing loss.

\* Defined as the use of technology that stimulates the senses of touch and motion, especially to produce in remote operation or computer simulation the sensations that would be felt by a user interacting directly with physical objects.

### Mumbled, muffled streaming TV

There's a line that Americans are repeating in their homes all over America as they watch TV these days, said Brian X. Chen in *The New York Times*: "What did he just say?" If you have trouble hearing your favorite streaming shows, you are far from alone. "All of my customers have issues with hearing the dialogue," says a home theater specialist

who has seen a continuing decline in audibility. Thin TVs with hidden speakers are an issue. But so is wild inconsistency in volume between channels.

There have been some efforts to help. Speaker company Sonos' soundbar offers a speech enhancement mode, and Amazon has rolled out a "dialogue boost" feature for a few shows. Sometimes these features help, sometimes not. "And if all else fails," turn on the subtitles.

# Illinois Passes Law Requiring Insurance Providers to Cover Hearing Aids

Sharon King, Advocacy Chair of our Chapter, reports that Illinois has recently enacted legislation that requires insurance coverage for hearing aids and related services for individuals of all ages who are hearing impaired. This legislation extends current legislation applicable to individuals under 18 years of age. The new legislation will be effective January 2025.

Illinois State Senator Dave Koehler (D-Peoria), who sponsored the legislation, stated that "Illinoisans shouldn't have to pay ridiculous fees for something that is necessary for their health and well-being", observing that "These devices [hearing aids] make daily routines attainable and allow a high quality of life for those who are hard of hearing."

Sharon King will follow the implementation of this legislation. We will keep you up to date in this newsletter on developments as they occur.
